



The Wattpad Read to Redeem Promotion

Terms and Conditions

NO PURCHASE NECESSARY TO PARTICIPATE OR RECEIVE A REWARD

The Wattpad Read to Redeem Promotion ("**Promotion**") is offered by Wattpad Corp. (the "**Sponsor**") in partnership with Naver.U.Hub Inc. ("**ThingsBook**", together with the Sponsor, the "**Brand**" where referenced below). The Promotion is offered in the fifty (50) United States, the District of Columbia, and Canada (the "**Promotion Area**"). The Promotion is void where prohibited or restricted by applicable law, including any territories where promotion licensing or registration is required, and is restricted in any territories sanctioned by the Office of Foreign Assets Control (OFAC) of the US Department of the Treasury, including but not limited to Crimea, Cuba, Iran, Libya, North Korea, Russia, Sudan, Syria, Somalia, and Venezuela. All applicable federal, state/provincial, and local laws apply.

Sponsor shall be entitled to interpret these official rules ("**Official Rules**") as needed, including without limitation, rules regarding eligibility, entries, deadlines, winners, prizes, and prize restrictions. By entering, entrant (and, with respect to Minors (as defined below), their respective parents/legal guardians) (collectively "**Entrant**" or "**you**") agrees to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters. Entrants who have not complied with these Official Rules are subject to disqualification.

1. **Promotion Period:** The Promotion starts at 1:00:00 PM EST on August 10, 2026, and ends at 1:00:00 pm EST on August 24, 2026 (the "**Promotion Period**").
2. **Eligibility:**
 - a. Entrants must be legal residents of the Promotion Area and at least are eighteen (18) years of age at the time of entry. Entrants who are less than the age of majority in their country/state/province of primary residence (a "**Minor**") must obtain prior written permission from their parent or legal guardian, who must agree, individually and on behalf of such Minor, to be bound by these Official Rules.
 - b. Employees, officers and directors of Sponsor, and the members of their immediate families (defined as spouse, domestic partner, parents, children, siblings and their respective spouses or domestic partners, regardless of where they reside) and households (whether or not related), are not eligible to enter or win.
3. **How to Enter:** Wattpad will share an announcement of the Promotion through Wattpad's notifications features and/or through its social media. During the Promotion Period:
 - a. Read one or more stories from the "Wattpad x ThingsBook Summer Reading List" available at <https://www.wattpad.com/list/1842250894> (the "**Reading List**") for at least thirty (30) minutes to be entered into the Promotion for Reward 1; or
 - b. Read one or more stories from the Reading List for at least sixty (60) minutes to be entered into the Promotion for Reward 2, in addition to Reward 1.
 - c. An Entrant may receive both Rewards described in this Section if they satisfy both reading thresholds during the Promotion Period.
4. **Rewards:**



- a. There is no fixed number of Rewards available to be won. Reward 1 consists of 30 Bonus Coins, valued at approximately \$0.15 USD. Reward 2 consists of 60 Bonus Coins, valued at approximately 0.30 USD (each a "Reward"). All Entrants who satisfy the applicable requirement in Section 3 [How to Enter] will receive the corresponding Rewards; there is no element of chance or skill involved.
 - b. All Reward details are at Sponsor's sole discretion. Rewards must be accepted as awarded and may not be substituted or transferred, except that Sponsor reserves the right, at its sole discretion, to substitute a reward of equal or greater monetary value if any Reward cannot be awarded as described or becomes unavailable for any reason. Rewards are not transferable, not for resale and have no cash surrender value.
 - c. Each Entrant shall be solely responsible for all federal, state, provincial and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the Rewards.
 - d. "Bonus Coins" are as defined in, and subject to, the Payment Policy (available at: <https://policies.wattpad.com/payment>). Bonus Coins expire within thirty (30) days of being earned. The Bonus Coins may be used to gain access to Wattpad Originals, however Wattpad Originals are not available in all regions. If Entrant is located in a country where Wattpad Originals are not available, the Bonus Coins will not provide access to Wattpad Originals. If Entrant normally has access to Wattpad Originals outside of this Promotion, Entrant's ability to use any Bonus Coins will not be affected.
 - e. Sponsor, ThingsBook and their respective parent corporations, affiliates, subsidiaries, and advertising, promotion and fulfillment agencies and all of their respective officers, shareholders, directors, employees, agents, representatives, licensees and assigns (collectively, the "Released Parties") have not made, nor are in any manner responsible or liable for, any warranty, representation, or guarantee, express or implied, in fact or in law, relative to any Reward, including but not limited to its quality, mechanical condition or fitness for a particular purpose. By accepting a Reward, each Entrant agrees to waive all recourse against the Released Parties if the applicable Reward or any component thereof does not prove satisfactory, either in whole or in part.
5. **Entries:** By entering, you agree to be bound by all Sponsor's Policies (found at <https://policies.wattpad.com/>), including the Content Guidelines, Terms of Service, and Privacy Policy (collectively, the "**Website Terms**"). You must complete the action(s) outlined in Section 3 [How To Enter] during the Promotion Period. Proof of transmission (screenshots or captures, etc.) does not constitute proof of delivery. Website's clock will be the official time-keeping device for the Promotion.
- a. Each qualifying reading session shall herein be referred to as an "**Entry**" (collectively, "**Entries**"). There is a limit of two (2) Rewards per Wattpad username and associated email address during the Promotion Period. Each Entry must be associated with a valid Wattpad username and email address.
 - b. In the event of a dispute regarding any Entry based on an email address, that Entry will be deemed made by the authorized holder of the primary email address associated with the Entry at the time of the Entry submission, and such Entrant must comply with these Official Rules. Entries generated by script, macro, robotic, programmed, artificial intelligence, or any other automated means are prohibited and will be void. The Sponsor will not be responsible for late,



lost, illegible, falsified, damaged, misdirected, mutilated, garbled or incomplete Entries, which will be void. Any Entries that do not satisfy the requirements set out in these Official Rules will be ineligible for entry into the Promotion. Any person who is found to have entered in a fashion not sanctioned by these Official Rules will be disqualified.

- c. All Entries become the permanent property of the Sponsor and will not be returned or acknowledged.

6. **Reward Fulfillment:**

- a. Rewards will be added to each Entrant's Wattpad Wallet associated with their Wattpad account within thirty (30) days of the Entrant completing the applicable reading thresholds. Upon crediting a Reward, Sponsor will be deemed to have awarded the Reward to that Entrant, who assumes full responsibility for the Reward.
- b. Sponsor reserves the right to review Entries for compliance with these Official Rules prior to crediting a Reward, and to withhold or reverse a Reward credited in error or obtained through ineligible or fraudulent means.

7. **Right to Void / Terminate / Suspend / Modify:** Sponsor reserves the right to terminate, suspend or modify this Promotion, in whole or in part, at any time and without notice or obligation if, in Sponsor's sole discretion, any factor interferes with its proper conduct as contemplated by these Official Rules. Without limiting the generality of the foregoing, if the Promotion, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole discretion of Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Promotion, Sponsor may, in its sole discretion, void any suspect entries and: (a) terminate the Promotion, or any portion thereof; (b) modify or suspend the Promotion or any portion thereof, to address the impairment and then resume the Promotion, or relevant portion, in a manner that best conforms to the spirit of these Official Rules; and/or (c) honor Rewards from among the eligible, non-suspect entries received up to the time of the impairment in accordance with Section 4 [Rewards]. Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process, the operation of the Promotion, violates the Official Rules, or acts with intent to annoy, abuse, threaten or harass any other person.

8. **Release / Limitation of Liability:** ENTRANTS HEREBY HOLD THE RELEASED PARTIES HARMLESS FROM AND AGAINST ANY THIRD-PARTY CLAIM ARISING FROM USE OF THE ENTRY(IES) OR ENTRANTS' PARTICIPATION IN THE PROMOTION, INCLUDING WITHOUT LIMITATION ANY CLAIM ARISING OUT OF OR IN CONNECTION WITH COPYRIGHT, TRADEMARK, RIGHTS OF PUBLICITY OR PRIVACY OR FALSE ENDORSEMENT. RELEASED PARTIES ARE NOT RESPONSIBLE FOR LOST, LATE, DAMAGED, MISDIRECTED, ILLEGIBLE, INCOMPLETE, DELAYED, INACCURATE, GARBLED, STOLEN OR MUTILATED ENTRIES, OR FOR ANY COMPUTER, ONLINE, TELEPHONE OR TECHNICAL MALFUNCTIONS, DELAYS OR HUMAN ERRORS THAT OCCUR IN THE PROCESSING, TRANSMISSION OR RECEIPT OF ENTRIES, OR FOR INACCURATE TRANSCRIPTION OF ENTRY INFORMATION, OR FOR ENTRIES THAT ARE STOLEN, MISDIRECTED, GARBLED, LOST OR DELAYED BY COMPUTER TRANSMISSIONS, OR IF, FOR ANY REASON, THE PROMOTION IS NOT CAPABLE OF BEING CONDUCTED AS PLANNED, INCLUDING BUT NOT LIMITED TO INFECTION BY COMPUTER VIRUSES, BUGS, TAMPERING, UNAUTHORIZED INTERVENTION, FRAUD, TECHNICAL FAILURES, OR OTHER CAUSES. The Released Parties do not assume any responsibility for (i) the incorrect or inaccurate capture of entry information and entries that fail to comply with these Official Rules; (ii) any loss, damage, or claims caused by an awarded Reward or the Promotion itself; or (iii) any failure of the Wattpad website or platform hosting these rules, including any problems, human or technical, printing errors, lost, delayed, garbled data or transmissions, omissions, interruptions, deletions, defects or failures of any telephone or computer lines, or technical malfunction of any computer on-line systems, servers, access providers, computer equipment, software, failure of any e-mail or entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from downloading any material connected to the Promotion, all of which may affect a person's ability to participate in the Promotion. Entry material/data that has been tampered with or altered is void.

Personal information collected from Entrants will only be used by the Sponsor to administer the Promotion and, only if consent is given at the time of entry, to provide the Entrants with information regarding upcoming promotions and/or events from the Sponsor and its affiliates. By entering the Promotion, each Entrant (or their parent or legal guardians if a Minor) consents to the manner of collection, use and disclosure of personal information as set out herein and in the Sponsor's privacy policy, which is available at <https://policies.wattpad.com/privacy>.

Please include in the email, the name of the Promotion, your name, your Wattpad username and associated email address, proof of your qualifying reading activity (e.g., a screenshot showing reading duration), and confirmation that you meet the eligibility requirements in Section 2 (including that you are 18 years of age or older). There is a limit of two (2) Entries per Entrant. Email Entries must contain all items outlined above; otherwise, they are void and will not be eligible for a Reward.
